\*CERTIFY YOUR PLANTED ACRES AT F.S.A. FIRST. THEN, SEND YOUR ACREAGE REPORT TO US. ACRES ON YOUR POLICY MUST BE THE SAME AS CERTIFIED AT F.S.A.!! YOU **MUST** SEND YOUR ACREAGE REPORT TO OUR OFFICE BY JULY 15 FOR SPRING CROPS, MAY 31 FOR OATS, NOVEMBER 15 FOR FALL WHEAT.
